

## **RESOLUTION IN SUPPORT OF AB 1930 (MEDINA, GONZALEZ, & QUIRK-SILVA)**

**WHEREAS**, Associated Students of San Francisco State University is the official voice of over 29,000 students at San Francisco State University whose purpose is to advance the welfare of San Francisco State University; and

**WHEREAS**, if AB 1930 (Medina, Gonzalez, & Quirk-Silva) passes, the future students of both San Francisco State University and the entire California State University (CSU) system will not be subjected to unreasonable and sudden additional A-G requirements in order to simply gain acceptance into the CSU; and

**WHEREAS**, it is the duty and focus of this Associated Students Board of Directors to support and represent vulnerable student populations, such as those who would be disproportionately affected by new barriers and hoops that additional A-G requirements would pose; and

**WHEREAS**, it is also the duty and focus of this Associated Students Board of Directors to ensure that the CSU remains accessible and equitable for all future and current students; and

**WHEREAS**, the CSU Office of the Chancellor has previously tried to impose a fourth year of Quantitative Reasoning to gain acceptance into the CSU, which we have previously as an AS Board of Directors written a resolution in opposition to such a change without proper study and analysis; and

**WHEREAS**, AB 1930 (Medina, Gonzalez & Quirk-Silva) would require the CSU to conduct an independent study with a third-party research organization to assess the full impact that an admissions policy change would have on all prospective students; and

**WHEREAS**, AB 1930 (Medina, Gonzalez & Quirk-Silva) would also require the CSU and University of California (UC) to coordinate and streamline with the California Community Colleges (CCC) if seeking to change their admissions policies; and

**WHEREAS**, Associated Students Inc., of California State University, Sacramento (ASCSU) has also passed a Resolution in Support of AB 1930 and a Letter of Support of 1930; and therefore, be it

**THEREFORE BE RESOLVED**, that Associated Students of San Francisco State University Supports AB 1930 (Medina, Gonzalez & Quirk-Silva), the bill regarding admissions policy changes in both the CSU and UC.
